# Major Changes to Reporting Panel

Prior to June 30, 2006, there are two credit union reports; a long form and a short form. All credit unions were required to file the long form in June and December. For March and September, credit unions with assets over \$10 million must file the long form and the others had the option to file a short form.

Prior to September 30, 2002, credit unions were required to file a CALL report to NCUA each June and December regardless of their asset size. If the asset size was over 50 million dollars on the December 31 CALL date they must report quarterly throughout the following year.
